- All documents shall be signed and stamped by the Supplier/Buyer.
- All documents, for the foreign companies, shall be notarized/ratified by the Egyptian embassy in the country of the Supplier/Buyer location, with hard copies.
- EGAS has the right to disapprove the registration of your company in case of failure to complete this form and/or failure in submitting any of the requested documents in the manner/form specified above.
- EGAS reserve the right to reject any registration request without giving any reasons.
- EGAS reserves the right to request additional information and/or documentation, at its sole discretion.
- The Supplier/Buyer shall sign EGAS's standard MSPA template following the completion of the registration process.
- In the event that the conditions do not apply to the Supplier/Buyer who is considered a branch of a group of companies, in this case the group will be registered if it complies with the conditions and submitted the documents set out in this form.
